SINGAPORE'S CREATIVE COMMUNITY CELEBRATES WORLD IP DAY WITH SPECIAL SCREENING OF "AVENGERS: AGE OF ULTRON" & MUSIC COMPOSITION PANEL DISCUSSION

SINGAPORE – In commemoration of World IP Day – this year themed 'Get Up, Stand Up. For Music.', the U.S. Embassy in Singapore and the Motion Picture Association (MPA), with support from Golden Village (GV) and The Music Society, Singapore (SGMUSO), jointly hosted a panel discussion focusing on 'Music Composition for the Screen' and a special screening of "Avengers: Age of Ultron" at GV Suntec City today.

Addressing over 100 guests from various government agencies, creative industry professionals and students, Guest of Honor, U.S. Ambassador to Singapore, Kirk Wagar, said, "It is essential that we continue to support the next generation of creators, composers and filmmakers. World IP Day is important for raising awareness about the value of creativity and intellectual property, and the need to create the best possible environment for the same to thrive. We are proud to be working alongside the Motion Picture Association to highlight and celebrate this occasion."

"We are honored to join MPA and the U.S. Embassy once again in recognizing the importance of intellectual property, both for the good of our culture and our economy," said Clara Cheo, CEO, Golden Village. "As stakeholders in the movie industry, we appreciate that for the industry to thrive, we must commit to IP protection, as well as create a legitimate marketplace for all creative works to flourish."

The panel, "Music Composition for the Screen", moderated by Stephen Jenner, Regional Director of Strategic Communications & Third Party Outreach, Asia Pacific Region, MPA, took a deep-dive into understanding the relationship between the moving image and soundtracks, and the current trends in the business. Panelists included Shabir Tabare Alam (Actor, Recording Artist & Composer of Shabir Music), THELIONCITYBOY (Rapper, Songwriter of BMBX/S.N.O./The Bedsty Group), Alex Oh (Film Composer - Bait 3D, Faeryville) and Syaheed (Country Manager & Trade Marketing Manager (Asia), Believe Digital).

Syaheed, who also serves as the vice president of SGMUSO, said, "Creators from Singapore and around the world depend on intellectual property protection in order to make a living from their hard work. Let's build an environment where the works of all creators are effectively respected and protected, including our talented musicians, filmmakers, cartoonists and writers in Singapore."

Rapper and songwriter THELIONCITYBOY said, "In the last year, Singapore has seen a new appreciation for contemporary local music. So this panel comes at a great time to educate and remind artistes and future creators to not forget and more importantly to respect the value of their IP."

Stephen Jenner from the MPA, said, "It's a pleasure for the MPA, in partnership with the U.S. Embassy and Golden Village, to take this opportunity to acknowledge the originality and creativity of the talent behind our favorite movies and music. This is a wonderful time to work in the creative industries, given the incredible digital production and distribution tools at our disposal. However, it is important to remember that the creative process is always one that requires great imagination, hard work and extraordinary commitment, and we should acknowledge creative work with the respect it deserves and honour intellectual property rights."

"Avengers: Age of Ultron" is a superhero film sequel to 2012's "Marvel's The Avengers". The film stars Robert Downey, Jr., Chris Hemsworth, Mark Ruffalo, Chris Evans, Scarlett Johansson and Jeremy Renner.
